I further understand and agree that Drumlins may change the terms and conditions of membership including but not limited to these automatic renewal provisions at any time upon written notice to me of any such change. Family memberships are limited to one spouse / significant other and two dependent children under the age of 21. Family members beyond this may require an additional charge.

Drumlins reserves the right to suspend or cancel membership due to non-payment of account. Checks returned for any reason are subject to a \$25 fee or the maximum allowed by law. The primary member agrees to pay all reasonable collection costs if this account should be placed with an attorney or agent for collection. All membership fees are non-refundable whether on his or her own initiative or by Drumlins, and a member will not be entitled to a refund if his or her membership is canceled, terminated, altered, or due to closure or limited use by governmental mandate. To operate a golf cart the driver must have a valid driver's license which allows them to operate a motorized vehicle and is responsible for any damages incurred to the golf cart or other property during use of the cart.
